## November

Members' Meeting At Maymont

The last VCA Members meeting was held at Maymont on November 19<sup>th</sup>, 2009. The meeting featured a presentation by Williamsburg textile specialist, Natalie Larson of Historic Textiles. Natalie's firm furnishes

accurate and authentic interior textile replications to museums, small house museums and private clients from Maine to South Carolina.

Natalie's lecture was an exploration into a few of the unique projects she has encountered. Many of the projects involved investigating and furnishing beds from historic sites such as the John Marshall House, Monticello, Prestwould, Mount Vernon, Peabody Essex Museum and the Metropolitan Museum of Art to name just a few. Other projects she spoke about included the Victoria Mansion in Maine with the only surviving Herter Brothers Turkish smoking room, the Gore Place packing trunk slip cover and the Sturbridge Village slip cover that survives, though without the unusual chair for which it was made. Natalie finished her presentation with details of a future conservation dilemma involving a fall-out shelter at the Marsh-Billings-Rockefeller Museum in Woodstock, VT.


## Announcements

The Membership Committee reminded everyone to renew their membership. And you could renew that evening and still be included in the directory and receive the regular rate.

The Outreach Committee chair Dale Wheary reported that they had a successful committee meeting. Since this is a new position they have been discussing how the VCA can contact constituents. They have developed goals and activities for the year to get people to participate. Ms. Wheary requested that everyone respond to Mr. Wallace's email questionnaire regarding the future of the VCA. This questionnaire among other goals will assist the outreach committee in drafting a brochure. The brochure is one of the goals the outreach committee would like to have completed before the Virginia Association of Museums' Annual Conference in March. The VCA is also cosponsoring a workshop at this conference titled "When to Call in a Conservator".

Fred Wallace reported that he, Valinda Carroll, and Dale Wheary met with Margo Carlock, Director of Virginia Association of Museums (VAM), and Jennifer Weiskotten, VAM Program Director, to discuss their parallel initiatives and look at future collaborative ideas. This meeting was very successful in educating the VAM staff on who the VCA are and how they can assist each other. They will update us more as they continue to meet but Mr. Wallace felt that it was a good first meeting.

**The Publications Committee** was not able to attend but Mr. Wallace reported on their behalf that submissions for the January newsletter need to be to Tracy Bernabo by December 28<sup>th</sup>.

The Programs Committee (Valinda Carroll and Tom Snyder) reported that the January meeting will be at T.K. Asian Antiquities in Williamsburg. The March

meeting will be at the James Monroe Museum in Fredericksburg and that date may have to be different from our usual meeting date so stay tuned. The presentation will be by Colleen Callahan and will include a tour of a textile exhibit. The May meeting will be at Hampton University Memorial Chapel.

The Education Committee was unable to attend but Mr. Wallace reported that he is working on a workshop for the spring that will be presented by Robin Hodgson, of RH Conservation Engineering, who has invented a new suction heat table system. Mr. Hodgson will be in the country for the AIC conference so Mr. Wallace is trying to find a date following the AIC conference.

They are also planning updates to the website. The website will also include a referral list which will include any conservators who would like to be listed as available for work.

Mr. Wallace wrapped up the meeting by reminding everyone that this is the VCA's anniversary year and the board welcomes all ideas about the future of the VCA.
