#### From Interstates 95 and 64

VIRGINIA MUSEUM OF FINE ARTS

- Take Boulevard Exit 78
- Follow Boulevard (Route 161 South) for 1½ miles.
- Turn right onto Kensington Ave. (Virginia Historical Society is at the corner).
- Turn left on Sheppard St and travel ½ block.
- The entrance to the parking deck is on the left.

### From Powhite Parkway and I-195 Downtown Expressway

- From I-195 take the Floyd-Cary exit.
- Follow Floyd Avenue east to Belmont (five blocks).
- Turn left on Belmont, and proceed 3 blocks to Stuart Ave.
- Turn right on Stuart and travel 1 block; the entrance to the parking deck is straight ahead.
- From the Powhite Parkway take the Cary St exit.
- Follow Cary St. east to Belmont (five blocks).
- Turn left on Belmont, and proceed 5 blocks to Stuart Ave.
- Turn right on Stuart and travel 1 block; the entrance to the parking deck is straight ahead.

The parking deck is open until 9 pm on Thursdays. Parking is free to VMFA members with membership card, \$3 per day for nonmembers. The parking deck can be accessed from the main museum entrance on Boulevard, or from the intersection of Sheppard St. and Stuart Ave.

# VCA Business Meeting Summary

November 18th, 2010 Virginia Museum of Fine Arts

Fred Wallace (VCA President) thanked the Virginia Museum of Fine Arts for their hospitality in hosting the business meeting. He also thanked the Refreshment Chairs, Mary Andrews and Sandy Jensen, for their work in preparing the refreshments.

Tracy Bernabo (Publications Chair) informed those at the meeting that the deadline for submission to the next newsletter is Thursday, December 23<sup>rd</sup>, and that the next newsletter would go out on December 30<sup>th</sup>.

Colleen Callahan (Programs Co-chair) gave the preliminary plans for a bus trip to the North Carolina Museum of Art in Raleigh. The trip is tentatively planned for a Friday in April. Bus embarkation will be in Richmond and Williamsburg. Cost is estimated to be \$30 to \$40. The bus will leave in the morning, arrive at the museum in the afternoon and depart for Virginia in the evening. A show of hands from the members suggested strong support for the trip. Fred Wallace informed those in attendance that the trip is in response to the opening of a new wing of the museum.

Dale Wheary (Outreach Chair) spoke of the planning of a Speakers Bureau that will reach out to student groups and collectors. A conservation clinic is also in consideration and will be offered to the various audiences. More information on these programs will follow in newsletters and future meetings.

Fred commented on the possibility of VCA studio tips session during a future members meeting. Anyone who has useful tips concerning collections care or conservation treatments is asked to contact the VCA through the website or to correspond directly with a board member.

Web Management Committee member Valinda Carroll described some of the recent improvements and changes to the VCA website, including the link to the VCA Facebook page and operation of the "Contact Us" tab. She explained that the VCA email address is

now active. Messages sent to the organization in general (info@virginiaconservationassociation.org), will be redirected as appropriate. The email system will automatically forward all messages to Fred Wallace (VCA President), Patricia Selinger (Web Management Chair), Valinda Carroll (Web Management Committee member) and Heather Logue (VCA Vice-President). As Vice-President, it will be Heather Logue's responsibility to answer email inquiries or forward them to the concerned Board officer or committee. A request was made to the membership to provide digital photographs taken during various VCA programs or that show conservation projects in progress. These photographs will be posted in rotation on the web page. A second request was made to anyone having a working knowledge of php scripts for assistance with the website. Scripts will be added to provide security to the forums and facilitate the use of encrypted forms for online VCA work.

Fred ended the business portion of the evening by giving thanks to those who have renewed VCA membership. New members in attendance at the meeting were asked to raise their hands so that they could be acknowledged and welcomed.

On Thursday, November 18th, more than 40 VCA members gathered at the Virginia Museum of Fine Arts to see the newly-constructed sculpture and decorative arts lab. After wonderful refreshments provided by Sandy Jensen and Mary Scott Andrews followed by a brief business meeting, Kathy Gillis, Head of Sculpture and Decorative Arts Conservation at the Virginia Museum of Fine Arts, spoke briefly about the museum's new lab, detailing the long process of designing, choosing the furniture and hardware and beginning to work in a busy objects lab. The lab, more than 5000 square feet, is nicely outfitted with rolling work tables that can be ganged together to form large impromptu work surfaces, a flexible overhead exhaust system and plenty of natural light from banks of windows including clerestory windows.

### **Topic: Climate Control for Historic Buildings and Collections**

The Association for Preservation Technology DC Chapter, in conjunction with the Washington Conservation Guild, requests presentations for our Annual Symposium to be held in Washington DC on March 24-25, 2011. Presentations are to address the challenges of balancing the needs of building preservation, museum collections and visitor comfort. The Symposium would like to explore the decision making processes related to the introduction of environmental controls, best practices for climate control, successes and failures (including lessons learned), and the utilization of green practices and technologies.

All presentations that discuss case studies should address one of the above topics and presenters are encouraged to demonstrate how the case study contributes to the field by providing in-depth analysis of what was learned in the course of the study or project.

Abstracts should be 250 to 300 words and must include the title, the name of the speaker or speakers, the address of the speaker and any institution they are representing, email address of the speaker and the speaker's resume. Students are encouraged to submit work that is relevant to the topic.

Presentations are to be 30 minutes in length with time for questions.

Abstracts are due January 10, 2010 and should be sent to APT DC at <u>info@aptdc.org</u> with a copy to <u>catherine\_dewey@nps.gov</u>.

Selection Notification/Speaker Responsibilities. Please read the following guidelines carefully.

Each presenter will receive a complimentary registration for the symposium, lunch included. Presenters will not be paid. All travel and additional expenses are the responsibility of the presenter.

If your abstract is selected, you will be notified by January 31, 2011.

Presenters are encouraged to use PowerPoint technology to enhance their presentations. No other audiovisual requirements will be permitted. PowerPoint presentations must be submitted to APT DC at a specified deadline date in order to preload presentation to avoid on-site slow downs.

#### **Selection Criteria**

All abstracts are peer reviewed by an APT DC/WCG-appointed committee. Each abstract is evaluated in four key areas:

- ✓ Originality
- ✓ Quality of the abstract (clearly defines outcomes, flows smoothly)
- ✓ Relevance/significance to the field of Historic
- ✓ Preservation
- ✓ Objectives
