nity for museum staff and volunteers to meet with first responders to learn from and develop partnerships to improve local planning efforts to protect heritage resources. The Crisis Communications panel discussion (Photo above) was held on the set of a Virginia Rep play. The participants also had a chance to see Historic Hanover Tavern's newly constructed education and events center.



Congratulations to VCA board member **Keri Ragland** for being awarded The Master of Arts in Historic Preservation Alumni Prize. The award is given each year to encourage and reward an outstanding first year historic preservation graduate student, and in 2015, it was Keri! She was awarded the prize based on her term paper "Sea Level Rise and Historic Structure Salvage" in which she evaluated historic structures listed on the National Register of Historic Places along the Outer Banks of North Carolina, and how they could be affected by the rising sea level. She proposed a matrix to assist with the



decision of which properties should be saved and which could be condemned to the sea. The matrix placed heavy consideration and preference on properties of local, cultural and income

driving significance and addressed properties based on a point system.

## VCA Members' Meeting September 24, 2015

In 2010, Mariners' Museum conservators began an ambitious project to create an operational replica of one of USS *Monitor*'s Worthington steam pumps using multiple molding methods, laser-scanning, computer-aided-drafting, fused-deposition-modeling, and several casting and machining techniques.

The presentation will provide an overview of the methods and challenges in reproducing the steam pump and highlight how the replication process has aided in the conservation of the original artifacts as well as show the potential of a project like this to be an avenue for conservation outreach.

VCA Members arriving for the meeting should use the \*\*business entrance\*\* (framed by large bronze doors) to the Mariners' Museum and wait at the security desk for a staff member to lead you back to the *Monitor* Center Classrooms. There is another event at the Museum that night and those attendees will be using the main entrance.

#### VCA Member Profile

#### Will Hoffman

#### Conservator—Mariners' Museum

Will Hoffman knew in college that he liked working with objects. He had always enjoyed visiting museums and art galleries, and this helped him gain interest in conservation and preservation. He is currently a senior conservator at the Mariner's Museum in Newport News.

Hoffman attended State University of New York College at Buffalo, where he double majored in Anthropology with a concentration in Historic Archaeology, and Art with a focus on sculpture centered around metal fabrication and bronze, iron, and aluminum casting. As he neared graduation, though, he was still unsure of what he wanted to do. "I never really thought about conservation until I participated in an archaeological field school at Old Fort Niagara," Hoffman said. "During the excavation we had the opportunity to go to the conservation lab and work with an object conservator who was cleaning the freshly excavated artifacts. While working in the lab, I found out that I enjoyed working more with the artifacts after they were out of the ground than in it."

Hoffman was able to blend his interests in art and archaeology through conservation. His work at the Mariner's Museum allowed him to work on steam engines recovered from the USS *Monitor*. He developed a method for safely disassembling components that have the consistency of hard chalk, what he considers one of his most challenging projects. One of the more fun aspects of his job involved the use of Nd:YAG lasers to remove corrosion products off a copy of Alfred Gilbert's "Eros" fountain from Sefton Park in Liverpool. Hoffman says he is not sure what the future holds but that there is always something enjoyable to do at the museum, especially when it comes to working on the *Monitor*.

# VCA BOARD RETREAT

July 18, 2015 Maymont

Current and outgoing Board members met in a retreat to create better continuity and to discuss the current state of the VCA and its future direction.

One of the main points of discussion was whether or not to move forward with hiring a consultant to help the VCA with a strategic plan to increase membership and to look at restructuring the Board itself. Outgoing President Rick Vogt expressed his belief that whether or not to hire a consultant is one of the most important decisions this Board will make as it may require changing the VCA mission itself. Pros and cons of hiring a consultant were discussed at length.

**Recruiting new members**: Main points of discussion centered around efforts to recruit new members from the ranks of conservators, students, and others who have an interest in conservation of material culture. The current membership is about 80. It has been around 100 in some previous years.

Historically the VCA was to help conservators stay in touch with one another and present programs of interest. This was before the internet made this type of interaction easier.

A decision was made for the Board to review the current membership roster at the October meeting and decide the best way to contact past members who have not renewed. It was also felt by most members that promoting conservation as a career is an important goal of the VCA. Some of the ideas for increasing membership included: 1. Institutional memberships in addition to individual memberships

and ask their directors to encourage VCA Membership; 2. speakers designed to draw in a general population audience such as Ron Hurst, Director of Collections, Conservations, and Museums at CW or directors of major house museums to discuss the need for preservation and conservation; 3. Marketing the VCA to historical based professionals and preservationists. Concern was expressed about the difficulties and expenses involved in programs open to the general public. There might be a problem finding a venue that the VCA could afford and the cost of publicity; and it might require a fee for attendees. Also, this would mean that the Program Committee might need additional help in arranging for more general programming; 4. Encourage members to bring colleagues to meetings—members meetings free to guests; 5. Make sure programs also held outside Richmond; 6. Explore pod casts of programs for 1 year; 7. Advertise programs through VAM; 8. Encourage student involvement by starting a scholarship program for workshops, conferences, etc; 9. Ride sharing sign-up online.

Reasons for new members to join the VCA include: Networking, social, professional growth, connecting with others in conservation fields, and continuing education. To help new members the VCA will ask current members to consider becoming a mentor and this will be added to the membership application. Also, remind Board members to introduce new members and visitors to the group and make them feel welcome. Patricia will explore getting name tags.

Consultant: Several Board members talked about the need for a consultant to help re-energize the VCA. Sue Kindred is one consultant who has been proposed and she spoke to the group at the May meeting about some of the things she could do for the VCA. After much discussion and a review of the survey by the Board, it was decided to ask the membership to vote on hiring a consultant. This will be done at the September meeting and perhaps on-line. If we proceed with hiring a consultant, we will formulate a scope of work and a time frame, and the Board will seek to interview several consultants and get a cost for this work.

#### Minutes of the Members' Meeting May 21, 2015

The May members' meeting was held on May 21, 2015 at Agecroft. The program theme was Preserving the Iraqi Jewish Archive.

The business meeting began with the **treasurer's report and budget proposal** by Nancy Beck. Nancy announced the new post office box: PO Box 7023, Richmond 23221. The proposed budget was accepted.

Next, Kate Ridgway discussed the upcoming "Alliance for Response" conference. Interested members should register through VAM. Valinda will put a link to their website on the VCA website.

Mary Scott Andrews asked for ideas for upcoming **programs.** We need 5, and they can come from anywhere in the state.

Patricia Selinger spoke about **Careers in Conservation**. The last event at the VCU library, which was also broadcast on YouTube, went the full 2 hours and had lots of good conversation and questions.

Outgoing VCA President Rick Vogt announced that he plans to continue working with the VCA after his term as president ends.

Dianne Roland read the ballot for **new officers and chairs** aloud. After each nomination, membership voted yes or no. The proposed slate passed unanimously.

Next, Vice President Marla Curtis suggested that the old board and the new board meet over the summer for a **retreat** to ensure a smooth transition.

Patricia Selinger mentioned that she has contacted a consultant who can make suggestions on how to grow our membership. The consultant, Sue Kindred, works with non-profits and looks at their structure to give them business strategies and organizational sustainability. Ms. Kindred told the members about some of the things she has done for other groups. Rick Vogt brought up the theorem that in any given organization, 20 percent of the members do 80 percent of the work. Sue said that has shifted to 3 percent doing 97 percent of the work. Sue also mentioned she would start by training the board. She works on a six month contract at \$2,500. Fred Wallace asked how to get people involved and participating. He mentioned that some members had left, and we needed to get them interested again. Sue mentioned letting people know the benefits of VCA membership.

A discussion ensued about getting the word out about programs which may appeal to other groups, or collaborating with other groups.

The meeting was adjourned and the program presentation began.



# Iraqi Jewish Archive Conservation Project Presented by Conservator Katherine Kelly May 21, 2015

On May 6, 2003, the 16 American soldiers from Mobile Exploitation Team Alpha, a group assigned to search for nuclear, biological, and chemical weapons, entered the flooded intelligence headquarters. The basement housed thousands of documents and books that were under four feet of water. A room in the basement was devoted to materials related to Iraq's Jewish community. Many soon realized the importance of this unlikely survival of books and manuscripts, which are part of the legacy of Iraqi Jewish experience.




The wet materials quickly became moldy despite efforts to dry them. The Coalition Provisional Authority arranged to store the materials in a freezer truck to stop further mold growth. They also requested the assistance of the National Archives and Records Administration in Washington, DC, which sent preservation experts to Baghdad in June 2003.

Local options in Baghdad to dry and care for the materials were limited, so with the agreement of Iraqi representatives, the books and documents were shipped to the United States for preservation and exhibition, after which they will be returned to Iraq.
