only attend meetings, but make the decision to support the group by agreeing to serve in some capacity as well.



# January Program

Thursday, January 19th, 5:30 p.m. sharp. Refreshments to follow. Wren Building, 111 Jamestown Rd. Williamsburg, VA 23185

Dr. Susan Kern will give a tour and presentation on the history and preservation of William & Mary's Historic Campus.

History Professor Dr. Kern was named the executive director of the Historic Campus in 2014, a position charged with the preservation and interpretation of the university's most historic buildings: the Wren, the Brafferton and the President's House and with research, writing and teaching about the early history of the College. Kern, who earned her doctorate in history from William & Mary, stepped into the role of chief preservation advocate for the College's historic buildings.

A visiting associate professor of history at William & Mary, Kern specializes in material culture of the American South and public history. Her research interests include how the material world influences human behavior and interaction; she is as interested in plantation field work, factory floor plans, and tools, as she is in consumer goods and decorative arts. She also studies how museums and historic sites make use of the recent and distant past. She has more than 20 years of experience in teaching and research with a focus on architectural history and historical archaeology. A prolific scholar, Kern has published multiple articles and reviews, and her award-winning 2010 book The Jeffersons of

Shadwell was submitted by Yale University Press for the 2011 Pulitzer Prize in History.

As executive director, Kern plans and manages all archaeological excavations on the Historic Campus in coordination with other campus departments. Within the Wren Building alone, she helps manage a schedule of more than 500 events a year. Kern is also responsible for the antique furniture and decorative arts in the President's House and President's Art Collection.

Conservation Technician at the VMFA attended the conference: The microfading sessions at the Eastern Analytical Symposium focused on the advantages, limitations and recent improvements of the microfading tester, which was originally invented by Paul Whitmore in the 1990's. Over the last fifteen years, several people have made improvements to Whitmore's initial design. Thirteen presenters from various parts of the world came together for this conference to discuss what has worked and what has not worked with the recent innovations.

Microfading is an accelerated aging test in which a high powered beam of light is aimed at an area on an object while a reflectance spectrometer is used to measure slight degrees of color change in the illuminated area over a period of a few minutes. The rate of change is used to estimate how much light an object can withstand before there is any noticeable color difference. This information can then be used to inform lighting and display guidelines for the individual object.

Several of the talks at the conference focused on the issues encountered with microfade testing. In some cases the microfade tester can overestimate or underestimate the fading rate of an object. One reason for this is that the lights used in a museum gallery are not the same type of light used in the microfade tester. Additionally, the beam of light in the microfade tester can cause heating and dehydration of the sample which can affect the data. Another issue is that not all objects are suitable for microfading (anything with texture or thick brushstrokes) because it is hard to focus the beam of light into crevices. Improvements to the initial design include adding a pen camera as well as using the Getty spectral imaging viewer to help interpret the data. Despite the limitations, there are also numerous advantages of the microfade tester. For one, the data produced from microfading test analysis can help conservators produce real numbers for curators and collections managers to consider when creating or adjusting lighting policies and display guidelines. One method of doing this is with a "Preservation Target", as discussed by Christel Pesme. This involves setting a goal for the ultimate display of an object (100 years, 500 years, 1,000 years?) and using the microfade test data to estimate how long and at what light levels an object can be displayed without risk of light damage over that length of time. Microfade testing can also be used as a screening tool. Objects can be tested prior to display and the data can be used to assign the object a lighting category and display guidelines on a per object basis. Microfade testing is a relatively recent invention and therefore will have some kinks to work out. However, this conference made it clear that many improvements have been and will continue to be made. The Virginia Museum of Fine Arts plans to purchase a microfade tester soon and we are very excited to participate in future developments of this extremely useful device.



**NOVEMBER PROGRAM** 

Ainslie Harrison, Assistant Objects Conservator, Virginia Museum of Fine Arts discussed her experience with working insitu at El Cano, Panama, a Pre-Columbian Site of Sito Conte.

Conservation work involved the stabilization and cleaning of a wide variety of materials including objects made of worked stone, whale and jaguar teeth, ray spines, shell, resin, ceramic, and gold. The gold was one of the most abundant and well preserved of the materials present, and offered an excellent opportunity to study fabrication techniques through technical examination and analysis.


# Congratulations: VCA member receives AIA Virginia Honors Award

#### VCA STUDENT SCHOLARSHIP GUIDELINES (UPDATED DECEMBER 5, 2016)

- -The Virginia Conservation Association will offer two annual scholarships of \$250 each to be used towards costs associated with furthering education in the field. Use of funds may include conference or class fees or another related use as approved by the Board. Applicants must be VCA Student Members to apply.
- -Applications will be accepted throughout the year and will be approved or declined by the VCA Board during the April and December Board meetings. Successful applicants will be notified within one week of the Board meeting and presented a check within the following 30 days.
- -As a condition of the award, recipients will be required to summarize their experience as an article for an issue of the VCA newsletter.
- -Applicants are welcome to apply again for consideration in the next year.

#### **Suggestions for applications:**

Applications should include a brief, one-page explanation of their proposed use of funds including information on the program, conference, class etc. Applicants should also explain their interest in conservation and how the VCA scholarship will benefit him or her in pursuing a career in conservation or a directly related field. Expenditures are welcomed but not necessary.
