

Letter from the President



NANCY BECK, VCA PRESIDENT

As we come to the realization that winter is almost over, our thoughts turn to renewal and change. Spring heralds new life and an opportunity for growth. In this vein, the Board of Directors of the VCA would like to inform the membership of the reporting of the VCA Task Force on Membership Development and Retention. The task force, consisting of Frederick Wallace, Beth Fulton, Mark Lewis and Carey Howlett, presented their initial summary of Responses to Interviews/ Surveys of current and past VCA members to the Board on February 2, 2017.

Based on the findings and our discussion of these results, we are planning on taking immediate action on three of the recommendations that were put forward.

One concern we hope to address during this membership year is the revival of our Annual Social Party. Many members commiserated about the absence of the Winter Party and therefore we are planning a May fete to immediately follow the Business portion of our membership meeting in Church Hill. Plans are still not solidified as to venue (it will be in or near St. John's Church) and whether we will have a covered-dish sharing of food or a catered affair, so don't be shy about voicing your opinions to any Board member!

Another requested opportunity is one for growth and development in the way of more technical or educational programs, including workshops aimed at professional development for our members. For this to happen,

we need greater input and responsiveness from everyone along with the willingness to serve on the Education Committee. A great class, program or workshop does not happen autonomously.

Third, we hope to organize community service conservation projects in the near future, where we can reach a broader audience and not only promote our organization but help to take care of some of the conservation needs of our richly historical Commonwealth.

March Program

Thursday, March 16th, 5:30-7:30 p.m. The University of Virginia Rotunda 1826 University Ave, Charlottesville.

Please join the VCA for a special tour of the restored University of Virginia Rotunda led by Mark Kutney, Architectural Conservator with the Office of the Architect for the University.

We will start with our usual networking/social time with refreshments from 5:30 to 6:00 in a classroom adjacent to the Rotunda. From 6:00 to 6:15, Mark Kutney will give a brief overview of the restoration project. At 6:30, Mark will lead a tour of the Rotunda starting at the top and working our way down to the basement. Once in the basement we will have time for questions and answers. An elevator will be accessible for the tour if needed.

This four-year project restored Jefferson's Rotunda that caught fire in 1895 (pictured on page 1) to some of its original design and enhanced the space to give way for additional study spaces and classrooms. While the Rotunda was closed to the public for two years, archaeological discoveries and custom architectural additions were made. Craftsmen installed a new copper roof over the dome (pictured above).

PLEASE NOTE: The actual tour of the building is limited to 30 VCA members only. We will reserve spaces via Sign-Up Genius only starting on March 1st. The first 30 people to sign up for the tour via Sign-Up Genius will be guaranteed a space. Should there still be

space left as of March 12, we will notify the membership and open the remaining spots to guests of VCA members. Although the tour is limited in size, we encourage all members to come to the networking/social time and to hear Mark Kutney's brief overview of the Rotunda restoration project.

GENERATIONS AND DYNASTIES:
RHODE ISLAND FAMILIES AND THEIR LEGACIES
CALL FOR FELLOWS

The Preservation Society of Newport County is now welcoming applications for one-year research fellowships, which will begin on September 1, 2017. Applications for six-month fellowships and sabbaticals will also be considered. Interested scholars are invited to submit proposals that will utilize Newport's historic and cultural resources to examine the topic of "Generations and Dynasties: Rhode Island Families and their Legacies", as it relates to history, culture, design, and/or the arts.

While Rhode Island was founded in the 17th century as a refuge for outsiders, the cosmopolitan trade culture and wealth of Newport soon gave rise to families of immense political, economic, intellectual, artistic, philanthropic and social influence. By the mid-19th century, the network of Newport's influential families extended across the world and the city was transformed by aspiring dynasts and newcomers to the established social network. How did these enduring families/family networks develop? How did they maintain or expand their influence? How did different social, economic and cultural communities within Newport define their leading families? What kinds of political, industrial and aesthetic marks did they leave? How did these historic prominent families interact with and impact each other? What are their legacies today? Topics may include (but are not limited to): history and material culture; architectural history; conservation; decorative arts history; horticultural and landscape history and design; social history; art and literature; preservation policy and theory. Broad interpretations and interdisciplinary approaches to this theme are highly encouraged.

Fellowship requirements: An M.A. or Ph.D. in a relevant academic field such as the history of art, architecture or the decorative arts, landscape design history, historic preservation, material culture, literature, cultural geography, history, and public policy as it relates to cultural heritage. Doctoral candidates conducting dissertation research will also be considered. Proven ability to work independently, organize and manage multiple projects and meet rigorous deadlines is necessary, as are strong research, writing, and public speaking skills.


Fellows receive a stipend of \$24,000, plus \$1,000 travel and research allowance and free housing in our newly renovated Berwind-Stautberg Scholars Center. Residence at the Preservation Society is required. All fellows should be prepared to deliver a public presentation of their project at the conclusion of their fellowship. The deadline for submission of materials is March 4, 2017. After reviewing all applications, fellowship finalists will be selected for in-person or telephone interviews.



VCA Outreach



ANDREW BAXTER

Many thanks to VCA President Nancy Beck for attending the AIA Virginia Honors event at the Virginia Museum in November of 2016. I'm also grateful for the piece in last month's Newsletter about the recognition, and for VCA member Laura Cameron placing me into nomination. My friendship and professional involvement with Nancy and Laura has grown with the VCA, as with many other friends and colleagues.

I wanted to share something about my history with this excellent organization. In the late eighties we moved from a suburb of Manhattan to Powhatan. Quite a huge change for sure, and the work transition was not as smooth as anticipated. After a hapless stint waiting tables at the Olive Garden (and mauling the birthday Italiano song numerous times) I saw a classified ad for a position at the VMFA. It mentioned working with conservation, and I thought this is my big chance. Turns out the position was mainly with the security department, and the conservation aspect was notifying the lab if I saw a dead bug inside a frame, or an equally pressing concern. The job did allow me to learn the museum inside out and to meet a lot of art people. Although most seemed a little weirded out by my uniform of raggedy blue blazer, pilled up clip on tie, and black polyester flairs. During my time at the VMFA I was fortunate enough to meet Sandy Jensen, a dear friend and accomplished conservator, who encouraged me to join the VCA. After much trepidation, I did join and found the group to be welcoming, supportive, and unpretentious. After being on the board and serving as membership co-chair I was elected to a two year term as President. It was gratifying to be able to give back to an organization that had contributed so much to my success as a conservator in Virginia and Washington D.C. During my tenure as President we were fortunate enough to have programs such as a behind the scenes tour by the Office of the Curator at The White House, the Special Collections at The Library of Virginia, and an evening hosted by Pam Kiecker Royall and Bill Royall to learn about their outstanding collection and restoration of the Gillette gardens at their Cary St. residence.

I encourage all current and prospective VCA members to enthusiastically contribute your ideas and support to help this fine organization continue to flourish.

January Program

The January VCA Members' Meeting opened at 5:30pm with an introduction by Programs Co-chair Maeve Bristow of Dr. Susan Kern, Executive Director, Historic Campus of the College of William & Mary in Williamsburg, Virginia. Dr. Kern began her presentation outside with a discussion of the different structures that comprised the Historic Campus, before leading the group into the Wren Building. The 28 attending VCA members and guests were shown through the various rooms including the Gallery on the second floor, the Blue Room, and the Chapel (pictured above) where they learned the history of use and restoration after the building suffered two fires. Updated technology, melding with historic authenticity, was pointed out to the members along the way. The tour ended with a fascinating peek into the basement rooms as the group followed a drain installed by Governor Alexander Spotswood in the early 1800's. Everyone was amazed to see the modern mechanical workings of the building tucked away underground, and felt privileged to have had the opportunity to meet Dr. Kern and hear about her work and hopes for the future of the Historic Campus. Before the reception with social mingling and refreshments, VCA President, Nancy Beck, called the members into a business meeting to allow for the forming of the Nominating Committee. Vice President, Carol Boyers Givens, encouraged all attending to consider serving on the VCA Board and brought forward Bill Ivev and Tom Snyder as members of the ad hoc committee. They were both voted in unanimously by the membership. Membership Chair Dotty Robinson distributed more printed VCA Directories and accepted four new members before the evening ended around 7:30pm.

VCA STUDENT SCHOLARSHIP GUIDELINES (UPDATED DECEMBER 5, 2016)

- -The Virginia Conservation Association will offer two annual scholarships of \$250 each to be used towards costs associated with furthering education in the field. Use of funds may include conference or class fees or another related use as approved by the Board. Applicants must be VCA Student Members to apply.
- -Applications will be accepted throughout the year and will be approved or declined by the VCA Board during the April and December Board meetings. Successful applicants will be notified within one week of the Board meeting and presented a check within the following 30 days.
- -As a condition of the award, recipients will be required to summarize their experience as an article for an issue of the VCA newsletter.
- -Applicants are welcome to apply again for consideration in the next year.

Suggestions for applications:

Applications should include a brief, one-page explanation of their proposed use of funds including information on the program, conference, class etc. Applicants should also explain their interest in conservation and how the VCA scholarship will benefit him or her in pursuing a career in conservation or a directly related field. Expenditures are welcomed but not necessary.
